Divisions:

- Leadline: Riders will be shown in-hand
- Walk-Trot Gymkhana Division: Open to Walk-Trot riders of any age who have not competed at any show, in any class, requiring a canter.
- Youth Gymkhana Division: Open to riders 17 & under.
- Adult Gymkhana Division: Open to riders 18 & over.
- Rescue Challenge: Open to all horses who were adopted from a horse rescue.
- Special Needs: Open to riders with special needs, riders may walk or ride their horses.
- Open Classes: Ride a Buck and Stick Horse Race open to all riders.

Please note, anyone competing in Walk/Trot is ineligible to compete in Youth or Adult Divisions. Horses can compete in Youth or Adult AND Rescue Challenge, however only their highest scoring division will be counted towards High Points. Only Youth, Adult, and Rescue are eligible for high points.

Please mark all classes the horse and rider listed on this page will be competing in. The cost for each class is \$10, with the exception of the Stick Horse class (\$20) which includes a stick horse to keep.

**DRIFTER'S DASH FOR CASH
LIABILITY WAIVER**

Under Colorado Law, an Equine Professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities pursuant to section 13-21-119, Colorado revised statutes.

Waiver, indemnity and release

In consideration of Stephen Malcolm Strachan, Drifter's Hearts of Hope, located at 9555 Deerfield Road, Franktown, CO 80116, (the "Premises") and Casey Jones Park (4189 Highway 86, Elizabeth, CO 80107) granting the undersigned the right to be a part of "Drifter's Dash for Cash" or participate in horse riding and handling activities ("equine activities") on the Premises as well as Casey Jones Park. I, for myself, my heirs, successors and assigns, and if I am a guardian of a minor, for such minor, his heirs, successors and assigns, hereby waive, release and discharge Drifter's Hearts of Hope, the property owner Stephen Malcom Strachan Trust dated April 19, 1974, Casey Jones Park, managers, agents, officers and employees (hereafter, collectively, "DHOH") of and from all claims, demands, damages, actions and causes of action of any sort, for injuries sustained to my person, the horses and/or my property, for whatever reason, including, without limitation, negligence by DHOH.

I assume all risks of injury to my person and property that may be sustained in connection with any equine activity conducted in and about the Premises, Casey Jones Park, or at any other locations as may be utilized by DHOH.

I hereby further agree to indemnify and save harmless DHOH against liability, damages, loss of expense arising from any bodily injury, including death, at any time sustained by me or my relatives, heirs, subcontractors, guests, permittees, agents, servants of employees or on account of damage to property arising out of, or in consequence of, the Premises, Casey Jones Park and equine activities including "Drifter's Dash for Cash".

I am 18 years of age or older, I certify that my attendance and participation in the stated equine activities is voluntary, and I have read and understand the foregoing Waiver, Indemnity and Release. I have inspected the Premises and I understand that equine activities are inherently dangerous and I assume the risk of all dangerous condition concerning the Premises and the equine activities, and I waive all specific notice of the existence of such conditions.
